Conditions of Competition

1. Dates

a) Two (2) Days Championship event (day1 36 Holes & Day2 18 Holes) will be held on
Monday 29th to Tuesday 30th April 2024

2. Venue

a) Laguna National Golf & Resort Club, 11 Laguna Golf Green. Singapore 488047

3. Eligibility

a) Entries are open to SPGA Professionals, Seniors & Amateurs with USGA Handicap Index 10.0 & below, as at 1st January 2024

4. Entries

a) All entries must be completed with **payment**, and subject for approval by SPGA Committee which reserves the right to accept or refuse, or having accepted, subsequently rejects any entry without giving reason for its decision. (Late entry not accepted).

b) **** Please be informed that last minute cancellation won't be allowed. Players are required to pay the tournament entry fees as stated in the entry form.**

5. Format

a) This **SPGA April PAR TEE Golf Series 2024** shall be decided by stroke play over 54-holes, in accordance with the Rules of Golf as approved by the R&A Rules Limited and with the Local Rules approved by the SPGA Committee.

b) There will be cut off this **SPGA April PAR TEE Golf Series 2024 after**

Guarantee the last player will receive S\$250/-

c) The winner of **SPGA April PAR TEE Golf Series 2024** shall be the player with the lowest gross aggregate score over the 54 holes.

6. Field Size

a) The **SPGA April PAR TEE Golf Series 2024** will be limited to max. of **100** participants

7. Draw

a) The draw for the first and second rounds will be made by the SPGA Committee prior to start of the Championship and will be posted on SPGA website - www.SPGA.ORG.SG

b) Day2 Round 3 draw will be based on the cumulative gross scores of the preceding rounds.

c) Players shall start at the time and in order indicated in the draw. No substitution of players and changing of starting times shall be permitted after the draw has been made unless authorized by the SPGA Committee

8. Decision of Ties

- a) Championship Division - In the event of a tie or ties for the first place, the Winner shall be decided by a hole-by-hole play-off depend on the golf club, to take place as soon as practicable.
- b) In the event inclement weather or other reasons which make the play-off impracticable, the SPGA Committee's decision to determine the Winner is final.
- c) Senior and Amateur Division Pro Test Players - In the event of a tie or ties for the first place, the winner will be decided on the lowest score for the last 18 holes (or the last 9 or 6 or 3 or 1 hole). If a tie still arises, the scores for the 2nd Round and, if necessary, the 1st Round will be treated in the same way until a decision is reached.

There will be NO REFUND of entry fee after the closing date or any withdrawal within 48 hours' notice unless MOH medical reasons where participants must show proof of a valid MOH Medical Certificate to SPGA. Entry fee is not refundable.

10. Closing Date

- a) Entries must be submitted to SPGA, as stipulated in the Entry Form, before 12.00 noon on 22 April 2024
- b) Incomplete entries and Late or verbal entries will not be accepted.
- c) Last minutes cancellation or withdraw or NO SHOW after closing date still need to pay for entry fee \$350/- together with documents from MOH certification only.

11. Suspension of Play for Dangerous Situation (Note to Rule 6-8b)

- a) The specimen Condition in the Rules of Golf is in effect
- b) All practice areas that are in the open shall be closed during suspension for a dangerous situation until the SPGA Committee has declared them open.
- c) A suspension of play for a dangerous situation and the resumption of play shall be signaled using the club's warning system.

12. Inclement Weather

- a) In the event that the first round of the Championship Division cannot be completed, it shall be continued the next day prior to the commencement of the second round.
- b) In the event that the second round of the Championship Division cannot be completed, it shall be continued the next day prior to the commencement of the third round.
- c) In the event that the third round of the Championship Division cannot be completed, the rounds shall be abandoned. The result of the Championship Division will then only be based on the completed minimum of two rounds.

13. Pace of Play

- a) Rule 6-7 (Undue Delay; Slow Play) will be enforced using the "Group Pace of Play" system.

14. Disputes or Doubt as To Procedures

- a) If there is a doubt as to the correct ruling, players are to refer to the Tournament Rules Official. If a Tournament Rules Official is not immediately available, a player (having notified his/her marker) may elect to play two balls in accordance with Rule 3-3 and obtain a ruling at the conclusion of the round, prior to signing and submission of the scorecard.

15. Tournament Rules Official / Referee

- a) The Tournament Rules Official/Referee's decisions on all matters pertaining to the Rules of Golf are final.

16. Distance Measuring Device

a) Measurement devices are permitted **ONLY** for distance reading, No “sloping” readings.

17. Conditions of the Competition

a) The specimen Condition in the Rules of Golf is in effect.
